Whereas the Trust as the owner is conducting a college known as Bhavdiya Educational Institute, Siwar, Sohawal, Ayodhya- 224126 herein after referred to as the said college.

And whereas the said college is affiliatted to Dr. Ram Manohar Lohia Avadh University, Ayodhya (U.P.) constituted under the Uttar Pradesh Act 1973, herein after refferred to as the said Unversity.

And whereas the Commission in carrying out its objects and functions has sanctioned grants out of its funds to thes said college.

And whereas in order to regulate and control the use of the grant that may be made by the Commission has required the Trust to execute this Indemnity Bond which the Trust has agreed to do.

NOW THIS INDENTURE WITHNESSED AND IT IS HEREBY AGREED AND DECLARED BY AND BETWEEN THE PARTIES AS FOLLOWS:

1. The Trust hereby guarantees and covenants with the Commission that every amount of grant that will be given by the Commission to the said college shall when received by the said college solely be used for the benefit and purposes of the said college in accordance with the terms and conditions of the grant and not for any other purpose or any other insitution run by the said Trust and in the event of any purpose other than the purpose of the said college or for any other institution run by the Trust, the same shall be refunded by the Trust without demur to the Commission on demand. The decision of the Commission as to the misuse of the amount of grant and as to the quantum of the amount payable by the Trust shall be final and binding on the Trust.

The Trust further covenants with the Commission that the Trust shall furnish to the Commission the balance sheet of the Trust every year along with the annual audited accounts of the said college managed or run by the said Trust. The said balance sheet and the Annual Account will be sent to the Commission within two weeks from the passing therof by the Trust and in any event before the closing of the financial year of the Trust.
- 3. The Trust hereby agrees to indemnify and keep indeminnified the Commission against any loss that the Commission may suffer on account of the improper or misuse of the grant or any part therof made by the said Commission to the said College or on account of non use of the said grant for the said college.
