WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, Ramau Devi Hemraj Verma Charitable Trust, Plot No.14/3/22, Street/Road-Hemkunj, Village/Town- Shringarhat, Post office- Ayodhya, Tehsil/Taluka- Sadar, Town/City- Ayodhya, State- UP, District- Faizabad(UP), Pin Code -224123 has submitted an application (Code No. NRCAPP-3530) to the Northern Regional Committee of NCTE for grant of recognition for conducting B.Ed. Course with an annual intake of 100 (One Hundred only) on 22/12/2012 in the name of Bhavdiya Educational Institute, Plot No. 1173, Khasara NO. 1173, Street Number-NA, Village/Town- Sebar, Post office- Badagaon, Tehsil/Taluka- Sohawal, Town/City- Sohawal, State- UP, District- Faizabad(UP), Pin Code -224126.

- 2. AND WHEREAS on scrutiny/perusal of veracity of the facts & figures as per the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of visiting team report including videography, the Northern Regional Committee in its 225th meeting held on 25th February to 01st March, 2014 is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.Ed. programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory, etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.
- 3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Bhavdiya Educational Institute, Plot No. 1173, Khasara NO. 1173, Street Number-NA, Village/Town-Sebar, Post office-Badagaon, Tehsil/Taluka-Sohawal, Town/City-Sohawal, State-UP, District-Faizabad(UP), Pin Code -224126 for conduction of B.Ed. course of Secondary level of One Year duration with an annual intake of 100 (One Hundred only) from the academic session 2014-2015 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject to fulfillment of the following conditions:-
 - I. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
 - II. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
 - III. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- 4. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.
- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year alongwith the statement of annual accounts duly audited by a Chartered Accountant.
- 6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
 - I. Copy of the Application Form
 - II. Land and Building Particulars
 - III. Staff Profile
 - IV. Recognition letter
 - V. Information for having fulfilled the norms & standard and other required conditions.
- 7. In case if the land is in the name of the Society/trust, you must transfer the land within six months in the name of the institution failing which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution

concerned to get the needful done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the stipulated time.

- 8. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
- 9. Further, if the institution is not satisfied with the order, it may prefer an appeal under section 18 of the NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the issue of this order.
- 10. This Order is issued in continuation of Circular No. NRC/Recognition/2014-2015/72478 dated 03.03.2014 issued by the NRC in this regard.

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- AND WHEREAS, the institution, Bhavdiya Educational Institute, Plot No. 1173, Khasara NO. 1173, Street Number-NA, Village/Town- Sebar, Post office- Badagaon, Tehsil/Taluka- Sohawal, Town/City- Sohawal, State- UP, District- Faizabad(UP), Pin Code -224126 has by affidavit consented to come under New Regulations and has sought for two basic units in B.Ed., which require additional facilities.
- AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students
 each, subject to the institution fulfilling the following conditions, namely:-
 - (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Northern Regional Committee, with required documents by October 31, 2015.
 - (ii) The institution for additional unit will be required to submit the required documents such as, land documents, non-encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents, if available, otherwise it can also be given to the Visiting Team at the time of inspection.
 - (iii) The Regional Committee shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institution shall not be permitted to admit students for the academic year 2016-2017.
 - (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith documents, if any, together with the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt, and such other documents as indicated in the revised recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- 4. Now therefore, in light of the aboubove, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Bhavdiya Educational Institute, Plot No. 1173, Khasara NO. 1173, Street Number-NA, Village/Town-Sebar, Post office-Badagaon, Tehsil/Taluka-Sohawal, Town/City-Sohawal, State- UP, District- Faizabad(UP), Pin Code -224126 for conducting B.Ed. programme of two years duration with an annual intake of 100 students, for two basic units of 50 students each, from the academic session 2015-2016 subject to fulfilment of the conditions mentioned herein before 31.10.2015.
- Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by
 other regulatory bodies like UGC, affiliating University/ Body. State Government etc. as applicable. The
 affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building
